Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

1. No longer printing any materials in hard copies – all paperwork is sent electronically.
2. No longer using couriers. All paperwork is sent electronically.
3. Encouraging training virtually rather than face to face

We project that carbon emissions will decrease over the next five years to 8.07 tCO₂e by 2029. This is a reduction of 50%

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline.

- Only sending materials to customers in electronic format
- No longer using couriers which were used on a daily basis previously
- Only using biodegradable tea and coffee bags

The carbon emission reduction achieved by these schemes equate to 5.0 tCO₂e.

In the future we hope to implement further measures such as:

- Not using air travel as a mode of transport for our trainers
- We are encouraging virtual over classroom-based training
